Executive Summary

The below report is an annual report on the certified minority and women business enterprise spend (MWBE). This report includes the Delaware Department of Transportation's (DelDOT) federally mandated Disadvantaged Business Enterprise subcontracting spend for federally assisted highway projects and voluntarily subcontracting information from central contracting. The purpose of this report is to: identify agency certified minority and women business enterprise spend; analyze the population of certified minority and women business enterprises; identify successes and opportunities for growth. It should be noted that the goal of the report is not diagnose the entire state supplier diversity process as reflected in the agency supplier diversity plans as well as the Supplier Diversity Council report, but rather provide a MWBE spend analysis report for fiscal year 2011. This report should also be used to enhance the respective agency supplier diversity plans for FY12. Highlights from the fiscal year 2011 are as follows:

- There was an approximate increase of 29% of the number of minority and women businesses that have received direct monies from the State from FY10 to FY11. This represents an approximate increase of 50 MWBEs;
- There was an approximate increase of 30% of minority and women business direct spend, which is defined as direct monies paid to a MWBE excluding subcontracting monies, from FY10 to FY11. Which is approximately \$12.3 million;
- The Executive Agency with the highest number of direct spend of certified minority and women business enterprises was Department of Health and Social Services (DHSS), with 49 MWBEs;
- The Executive Agency with the highest direct spend for certified minority and women business enterprises was Department of Transportation, a total of \$7.65 million;
- In FY11 48% or 131 of the total MWBE vendors increased direct contracted business revenues from the State compared to FY10;
- In FY11 54 or 23% of the MWBE vendors represented new businesses compared to FY10;
- In FY11 Government Support Services (GSS) MWBE direct spend under contract increased by approximately \$7.6 million or 220%.

It should be noted that the data below is comparison from the previous year and should not be used as a baseline for measuring success or sustainability, but as an observation of identifying the dollar amount for certified M/WBEs an agency utilized in the respective year. - There was a 30% overall increase of MWBE spend from FY10.
- Department of Correction (DOC), Department of Transportation (DTI) and Department of Safety and Homeland Security (DSHS) increased the dollar amount significantly from FY10.
- It should also be noted the Department of Technology and Information and the Department of State, represented significant percentage increases from previous year although the dollar amount was not as significant as the aforementioned agencies.

Quantity of Contracted Minority and Women Business Enterprises

The below table identifies the number of direct contracted certified minority and women business enterprises. All executive agencies except Department of Natural Resources and Environment Control (DNREC) showed increases from previous fiscal year.

Table highlights

- There was a 28% overall increase of MWBE vendors from FY10.
- Department of Health and Social Services (DHSS) utilized the most MWBE vendors in FY11.
- Department of Correction (DOC) showed significant increase from previous fiscal year with an increase of utilization of 15 MWBEs.
- The school districts accounted for the largest number of MWBEs and also had the highest number MWBE increase of 21.

- The construction NAICS coded minority and women businesses are approximately \$16 million of MWBE spend, which is 30% of total minority and women business enterprise spend.
- The professional, scientific, and technical Services NAICS coded minority and women businesses are approximately \$16.6 million of MWBE spend, which is 30% of total minority and women business enterprise spend.
- The wholesale trade NAICS coded minority and women businesses are approximately \$10.1 million of MWBE spend, which is 19% of total minority and women business enterprise spend.
- The highest concentration of certified minority and women business is in Professional, Scientific, and Technical Services sector.

Minority and Women Business Subcontracting/2nd Tier Report

Government Support Services has received subcontracting information on seven central contracts. It should be noted that this is a new request in the reporting process and we anticipate as new contracts are awarded vendors will be more responsive to reporting MWBE subcontracting spend.

- Office Depot, Fastenal, Fischer Scientific, L-3 Communication, Staples, Grainger and USA Mobility submitted 2nd tier information.
- There was an increase of 125% from the first half of FY11.
- The submitted 2nd tier reports accounted for approximately 50 MWBEs.

Delaware Transit Corporation (DTC)

There was approximately \$62 million in the State financial system labeled as miscellaneous to the Delaware Transit Corporation. Although DTC is not an executive agency efforts have been made to continue to collect MWBE data in FY12.

- In FY11, a total of \$577,769.40 was distributed among 14 certified MWBEs.
- Three of the MWBE firms are on Government Support Services central contract.
- Two of the vendors attended the Contractors Assistance Participation Series (CAPS).
- One MWBE vendor accounted for approximately 35% of the total spend and it should be noted that this MWBE was made aware of the opportunity from OMWBE's outreach efforts.

Delaware State Housing Authority (DSHA)

DSHA made significant efforts to identify MWBE spend for pass thru funding.

- The certified MWBE direct spend represents approximately 4.9% of DSHA total spend.
- There was approximately \$4 million reported for self certified MWBEs in the Community Development Block Grants and Home program.
 - One self certified MWBE accounted for 95% of the MWBE spend for the Home program.

Federal Disadvantaged, Minority and Women Owned programs

The Delaware Department of Transportation (DelDOT) is a recipient of funds from the USDOT and DNREC and DHSS are recipients of Environmental Protection Agency (EPA) funding, which have disadvantaged business enterprise (DBE) goals. DelDOT is the only agency with a robust public works subcontracting process and this presents an opportunity to implement similar system statewide. The below table reflects the DBE subcontracting payments for FY11 to FY10.

Table Highlights

- 24 different DBEs subcontracted with DelDOT and subcontracting payments totaled \$6,920,209.07.
- Although the sum total DBE payments decreased compared to FY10 there was an increase in participation from FY10 for male minority businesses.

Statewide Recommendations for Supplier Diversity

Improvements

- a) The Contractors Assistance Participation Series (CAPS) training model achieved great success based on partnerships in the public and private sector. With the participation from major prime contractors, industry experts and business development organizations such as Skanska, the Small Business Administrations, EDiS, Turner Construction, Pettinaro, Associated Builders and Contractors of Delaware, Division of Facilities Management, Bancroft, HR Strategies, The City of Wilmington, Surety Bonding Associates, Cheyney University's Disadvantaged Business Enterprise Supportive Services Center, M&T Bank, First State Community Loan Fund, Construction Project Management Services, Inc, InSource Help, the Procurement Technical Assistance Center (PTAC). It is recommended that this model be broadened to capture additional industries.
- b) Forecast potential upcoming opportunities, based on contract expiration dates and create an environment to encourage partnerships and transparency. This has been consistently practiced by Government Support Services (GSS) and the Department of Health and Social Services. (DHSS), which could have contributed to the high participation among MWBE vendors.
- c) Engage agency financial personnel to increase the integrity in data analysis by reviewing all vendor spend data with OMWBE. In the absence of a complete vendor management system, this will ensure the accuracy in MWBE percent spend analytics.
- d) Encourage use of labeled MWBEs on the Government Support Services central contracting web site if contract is multi awarded (i.e. staffing, furniture, fasteners, network services, network hardware, dry cleaning services, towing services, packaged software & Microsoft Select Software). This will increase the MWBE spend for MWBEs that have already been awarded contracts.
- e) Report success, challenges and opportunities to the Office of Minority and Women Business Enterprise and provide Cabinet level support for supplier diversity reporting.
- f) Leverage open enrollment contracting opportunities such as the vendor IT staff augmentation contract. These types of contracting arrangements allow greater detailed analysis of exposure to contracting opportunities.

- g) Develop a method to identify the vendor socio-economic demographics of the vendor population. Currently, there is not a process to identify the entire population of vendors including industry type, nonprofit status, minority or women business classification, veteran owned status etc. This will result in greater accuracy of vendor spend analytics and potentially increase the opportunities for MWBEs.
 - a. An initial complementary analysis by D&B – Dun & Bradstreet identified approximately 30 veteran owned businesses that were on Government Support Services (GSS) central contract compared to the 5 currently listed.
- h) Participate in the Governor’s Entrepreneurial Conference, the City of Wilmington’s MegaBizfest and communicate and coordinate any agency outreach workshops with OMWBE. A report of the liaison participation in outreach events can be found in the appendix.
- i) Encourage applicable businesses to complete OMWBE certification. Each agency MWBE liaison has a listing of contracted self-registered W-9 minority and women contracted vendors. This will result in an increase of certified MWBE spend for Delaware.
- j) Request construction contractors and all other vendor(s) to report minority and women business enterprise subcontracting spend to the Office of Minority and Women Business Enterprise utilizing the subcontracting form posted on the OMWBE web site.
- k) Forward awarded contractors information and prebid attendee information to central contracting to post bids.delaware.gov to increase transparency.
- l) Utilize OMWBE database for smaller purchases not on contract and report to OMWBE using the under threshold solicitation form and provide Cabinet level support for reporting.
- m) Support Government Support Services contract delegation process, whereby increasing transparency and outreach to MWBE vendor community.

Agency Specific Highlights and Recommendations

Executive (OMB)

- An analysis of the data identified Human Resource Management - Statewide Training and Criminal Justice Council as the only two divisions, which accounted for the only two MWBEs that were not on a Government Support Services central contract, which indicates a greater need for exposure for under threshold opportunities.
- Although the Division of Facilities Management accounted for approximately 80% of the agency MWBE spend, there were minimal results for non advertised small public works projects secured by contractors on the DFM contractors' registry, which was created to expose MWBE to smaller projects.
- The Government Support Services (GSS) contracting staff has increased awareness of central contracting opportunities using sourcing tools including the OMWBE directory and the Dynamic Small Business directory. In addition to increasing outreach initiatives, the contracting team continued to increase transparency and provide tools to even the playing field by posting all relevant business intelligence data on mymarketplace.delaware.gov.
 - The amount of MWBE direct spend for GSS managed contracts increased from \$3.5 million in FY10 to \$11.2 in FY11, which is approximately an increase of \$7.4 million.

Delaware Economic Development Office (DEDO)

- An analysis of financial data revealed, DEDO provided approximately \$60,000 in financial assistance to four certified MWBEs.
 - Two of the firms increased their business with the State from FY10.
- The procurement opportunities were minimal, but the office utilized six MWBEs that were not on the GSS central contract and utilized a MWBE for significant economic development project.
- Foster an environment conducive of supplier diversity and encourage diverse business relationships with financially assisted companies with economic development funding for example Johnson Controls, Fisker, Bloom Energy and former Valero plant and request MWBE subcontracting information for respective project.
- The agency can be a potential resource to research and provide support for companies that are experiencing bonding challenges.

Delaware State Housing Authority (DSHA)

- The agency liaison worked with OMWBE to increase transparency for agency pass thru funding by reporting Community Development Block Grant Information.
- The agency included a panel on supplier diversity at the Governor's Housing conference.
- It is recommended the agency liaison continue to work with OMWBE to assist in identifying all certified MWBEs and leverage the OMWBE database to run Access queries to ensure all MWBE were identified in addition to strongly encouraging self certified MWBEs to go through the official OMWBE certification.

Department of Technology & Information (DTI)

- Data analysis revealed an increase in purchases from the Government Support Services (GSS) central contract for MWBE vendors for office furniture and audio visual services.
- The agency liaison worked with SHI and Microsoft to complete the Microsoft change of reseller process for both of OMB's master agreements and as a result of the coordinated efforts between the vendors and DTI, the MWBE certified vendor was transitioned as the new reseller with minimal inconvenience.
- The department also utilized two MWBE for smaller non advertised purchases not on central contract.
- DTI co-sponsored the vendor IT staff augmentation open-enrollment contracting opportunity.
- The department supported the Government Support Services contract delegation process.
- It is recommended that DTI continue assisting in the technology purchases and assist in instructing the agencies on opportunities to increase supplier diversity.

Department of State (DOS)

- The data revealed a significant amount of the agencies funding was awarded to for IT temporary personnel services and general IT services. This may present an opportunity to utilize the IT vendor managed staffing contract to increase opportunities for MWBEs and utilize the MWBEs on the Government Support Services central contract.
- The agency's significant increase from FY10 can be attributed to increased utilization from Government Support Services central contract in addition to increased exposure to small non advertised opportunities.
- The agency has included OMWBE in business development opportunities such as the Exporting Initiative.
- The Division of Professional regulation has been identified as an excellent entry point to recruit applicable business and encourage certification.

Finance

Approximately 80% of the agency MWBE spend was distributed to one vendor for public relations and advertising.

- The data from the W-9 online form is a critical data element that assists with outreach and determining potential MWBE and veteran owned business. The entire table with all data elements should be forwarded to OMWBE on a quarterly basis.
- The agency liaison was extremely active in recruiting the W-9 self registered MWBEs, assisting OMWBE identify accurate spend analysis and requesting subcontracting information from prime vendors.
- It is recommended the agency develop relationships with companies that provide lottery services. This industry has been identified in many states as a way to increase supplier diversity.

Department Health Social Services (DHSS)

- The data revealed the agency had the highest number of MWBE utilization for small non advertised purchases, which are represented by the significant sum total of purchases under \$50,000 not on identified Government Support Services (GSS) central contract.
 - There were approximately 35 MWBE vendors with sum totals for FY11 under \$50,000
- There was approximately \$4.4 million spent with medical transportation company and this presents a significant opportunity for subcontracting reporting.
- The agency liaison and representatives participated in all requested outreach events and provided support when requested from OMWBE.
- Approximately 44% of the total agency MWBE spend was driven by DHSS contract vendors and 36% was central Government Support Services (GSS) central contracts.

Division of Services for Children Youth and Families (DSCYF)

- There was approximately \$20.6 million distributed for comprehensive health services. This could present an opportunity for further transparency and preparing applicable MWBEs to respond to future opportunities. It should be noted there was a significant spike in the FY11 spend data compared to FY10 data. The FY10 methodology extracted hospital and rehabilitation data from the adjusted spend which could have accounted lower department spend in FY10
- Management and Business Professional services accounted for approximately \$2.6 million of the agency FY11 funding classification, which represents an opportunity for transparency and inclusion.
- The agency will begin to collect gender and ethnic data for day cares in the licensing process.

Department of Corrections (DOC)

- Although the agency showed a significant increase in the dollar amount awarded to MWBEs, the increase was attributed to one vendor in the healthcare/pharmacy industry.
- There was also a significant MWBE spend within the HVAC industry and medical testing industry.
- The agency data also revealed two MWBE construction companies that sum totals were under the mandatory advertised threshold, which indicates utilization for MWBE for small construction projects.
- There was approximately \$32 million distributed to two non MWBEs for personal care services and rehabilitation services which may present an opportunity for MWBE 2nd tier reporting and potential partnering opportunities for MWBEs.

Department Natural Resources and Environmental Control (DNREC)

- Three MWBE vendors accounted for 70% of spend and industries were IT, environmental and engineering.
- The remaining 30% of MWBE's average spend was approximately \$10,000 and which potentially indicates the platform for growth in FY12.
- The agency data indicated the opportunity to increase utilization of MWBEs for specific products/services on GSS central contracts with multiple vendors such as office furniture, lubricants, portable toilets and temporary staffing.
- It should be noted that there was a significant increase in the adjusted spend calculation from FY10. This is as a result of different accounting system coding and inclusion of Environmental Protection Agency (EPA) funded projects revolving loan fund for sewer construction and weatherization.
- It is recommended the agency increase transparency for agency pass thru funding and submit requested supporting information for contracting opportunities .
 - Environmental Protection Agency (EPA) funding to counties – Encourage the prime contractors and respective counties to report this information to the agency or the Office of Minority and Women Business Enterprise.
 - Energy Office –Energy Efficiency and Conservation Block Grant Program.

Department Safety Homeland Security (DSHS)

- 85% percent of the MWBE spend was attributed to two vendors successfully bidding on agency specific contract which were public relations and video surveillance.
- Community outreach, janitorial services, IT services and construction were all industries utilized by the agency for MWBEs that were not on central contract. This could potentially present the opportunity for growth in FY12.
- There was approximately \$10.1 million awarded for management and business professional consulting services. It is unclear, what specific services were utilized and greater transparency could present an opportunity for 2nd tier reporting and non advertised opportunities.

Delaware Department of Transportation (DOT)

- Agency representatives participated in all outreach events in addition to participating in a total of eight certification workshops. It is recommended that a more integrated approach be leveraged, to discuss how to do business with the agency and discuss the agency supportive services for disadvantaged business enterprises.
- The agency has identified methods to collect subcontracting payment for federally funded highway projects and this represents a significant amount of MWBE dollars. It is understood that it will take additional resources, but this represents a significant opportunity to increase opportunities for MWBEs on construction and consulting projects.
- The agency represented one of the highest sums for MWBE in direct contract award dollar amounts. This could potentially be a result of the federally funded disadvantaged business enterprise program and supportive services provided for DBEs.
- It is recommended that the agency identify if an awarded consultant on the shortlist is a MWBE, similar to mymarketplace.delaware.gov, to increase the visibility of MWBEs.

Department of Labor (DOL)

- Data analysis reviewed approximately \$2.1 million for training and education. This may present an opportunity to include MWBEs in the strategic plan for future opportunities.
- A small amount of funding was labeled for auditing services to large, prime contractor which could have presented an opportunity for MWBE to be included in the solicitation.

Agriculture

- Although the MWBE spend was minimal for this agency, line item details analysis reveals that the agency can increase the communication for applicable MWBEs to certify with OMWBE.
- It is also unclear the specific services contracted to the University of Delaware for management and professional services.
- The agency liaison played a critical role in communicating the importance of 2nd tier reporting to a major supplies vendor.

National Guard

- Although the agency MWBE spend was less than FY10, it should be noted the agency liaison has submitted reports to OMWBE displaying the outreach for under threshold public works projects.
- As a result of receiving federal funds, the agency can leverage the federal supplier diversity reporting metrics for the state funded projects.

Department of Education (DOE)

- There was approximately \$4.9 million awarded to the University of Delaware for education and training services, management and business professionals and administrative services. It is recommended that greater transparency be applied to these opportunities, whereby increasing opportunities for MWBEs.
- The agency utilized three MWBEs that were not on Government Support Services (GSS) central contract, which is an indication of communicating non advertised opportunities to MWBEs.
