FY13 Bond Bill Opportunities:

House Bill 410 (Bond and Capital Improvements) was enacted on July 1, 2012. This bill provides detail on anticipated spending by Agency and sub-divisions for FY 13 (July 1, 2012 – June 30, 2013).

This summary is to provide a high level view of funding outlined in the Bond Bill for various projects the State may embark on during FY13. More importantly, it represents information by Agency and is intended to assist suppliers within the State's Supplier Diversity Community. Business enterprises outside of this community may also utilize this information. For a complete version of the Bond Bill please read [House Bill 410](#).

While anticipated spending in several categories is projected to be slightly lower during FY13 than in FY12, numerous opportunities are available. The information in this report, while focused heavily on diversity suppliers, is not intended to preclude other businesses from submitting proposals or participating in State Opportunities. Rather, it is intended to provide a view into the opportunities available and act as another form of outreach.

The information below represents anticipated and approved spending, by Agency, for FY13. There are approximately \$37 million dollars available from [Public Works Opportunities](#) remaining for Agency projects.
